Dear Customer:

On July 16, 2012, Emerald Pointe Utility Company, Inc. (Company) submitted a request for increases in its annual water and sewer operating revenues to the Missouri Public Service Commission (Commission). The reason for the increases is to cover increases in expenses and investments in the Company's facilities.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual water operating revenues of \$13,000 (approximately 10%) and an increase in its annual sewer operating revenues of \$186,000 (approximately 194%) At the end of this notice is a table that compares the Company's current residential customer rates and the proposed residential rates. Though not reflected in the table, the Company is also proposing to increase the rates for customers served by 1" and 2" meters the same percentage increase (to attain the overall aforementioned revenue increase) as the 5/8" meters percentage increase.

To provide comments regarding the Company's revenue increase request, or comments regarding service-related problems, please contact the Commission Staff and/or the Office of the Public Counsel (Public Counsel) within 30 days of the date of this notice. Your comments should include a reference to case numbers WR-2013-0017 or SR-2013-0016.
