**APPLICATION TO INTERVENE OF  
THE MIDWEST ENERGY USER'S ASSOCIATION**

COMES NOW the Midwest Energy Users' Association ("Applicants"), pursuant to 4 CSR 240-2.075 of the Missouri Public Service Commission's Rules of Practice and Procedure and the Commission's July 27, 2009 *Order Directing Notice, Suspending Tariff, Setting Hearings and Directing Filing*, and for its Application to Intervene respectfully states as follows:

1.       The Midwest Energy Users' Association is an unincorporated association of large users of electricity in Missouri and other Midwest states. Relevant to the immediate proceeding, some of the members of the Midwest Energy Users' Association are Wal-Mart Stores, Inc. and Best Buy Co., Inc., both of which are large users of electricity provided by AmerenUE. The Midwest Energy Users' Association expects to know of additional members that will help to fund this effort in the near future and will notify the Commission at such time as those members become known.

2.       The matters to be considered in this case and the Commission's determinations thereon, could have a direct and significant impact on Applicants' cost of energy service and the manner in which it is supplied. Therefore, granting this proposed intervention to the Applicants would serve the public interest and would assist the Commission in development of a more complete record.

3. As large user customers of AmerenUE, the Applicants have a direct and immediate interest in these proceedings that is different from that of the general public. While Applicants do not at this time have sufficient information to assert a position on this investigation, they reserve the right to assert positions after they have had an adequate opportunity to examine the record, and any documentation of other parties filed herein.
