RESPONSE TO ORDER DIRECTING FILING

1. On January 7, 2003, the Commission issued an *Order* directing Green Hills Telephone Corporation ("Green Hills") to either: (a) file a document showing that it is authorized to do business in the state of Missouri as Green Hills Telephone Company; or, in the alternative, (b) show why it should not be required to file such a document.

2. The Agreement between Green Hills and Verizon Wireless mistakenly refers to Green Hills as "Green Hills Telephone Company" instead of "Green Hills Telephone Corporation."

3. Green Hills requests leave from the Commission to correct this error and file an Amended Application and Amended Agreement as soon as representatives from Green Hills and Verizon Wireless can execute such a document.

4. The relief requested should not prejudice any party to this case because the only change to the Agreement and the Application will be the replacement of the word "company" with the word "corporation."
