UNION ELECTRIC d/b/a AMEREN MISSOURI'S AND CUIVRE RIVER ELECTRIC COOPERATIVE, INC.'S JOINT MEMORANDUM OF LAW IN SUPPORT OF MOTION TO DISMISS FOR LACK OF SUBJECT MATTER JURISDICTION AND FOR A DETERMINATION ON THE PLEADINGS

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) and Cuivre River Electric Cooperative, Inc. (Cuivre River) pursuant to 4 CSR 240-2.117(2) and 2.080(16), and for their *Memorandum of Law in support of the Motion to Dismiss for Lack of Subject Matter Jurisdiction and for a Determination on the Pleadings*, regarding the request for a change of electric supplier filed by Thomas L. Chaney, pursuant to Missouri Public Service Commission (Commission) rule 4 CSR 240-2.117, states as follows:

I. Introduction and Summary

Commission rule 4 CSR 240-2.117 authorizes the Commission to decide any case or issue on the pleadings under appropriate circumstances and provides that "the commission may grant the motion for summary determination if the pleadings, testimony, discovery, affidavits, and memoranda on file show that there is no genuine issue as to any material fact, that any party is entitled to relief as a matter of law as to all or any part of the case, and the commission determines that it is in the public interest." 4 CSR 240-2.117(1)(E). As discussed below, the Commission lacks subject matter jurisdiction to grant the relief sought by Mr. Chaney because Ameren Missouri lacks the power to serve Mr. Chaney's property. Thus, Cuivre River and Ameren Missouri are entitled to relief as

a matter of law, and indeed the Commission is required as a matter of law to dismiss Mr. Chaney's application.

The Commission's rule for determination on the pleadings is "similar to judgment on the pleadings," and is designed to "make litigation before the Commission more efficient and less costly for each entity and each person involved." The Commission has previously held that the public interest favors resolution of a case or an issue by summary determination when possible so as to avoid the time and cost required to hold hearings on a matter. "Moreover, the public interest clearly favors the quick and efficient resolution of this matter by summary determination without an evidentiary hearing inasmuch as '[t]he time and cost to hold hearings on [a] matter when there is no genuine issue as to any material fact would be contrary to the public interest." ²

Judgment on the pleadings is appropriate where the moving party has clearly established that no material issue of fact remains to be resolved and "if, from the face of the pleadings, the moving party is entitled to a judgment as a matter of law."³

In this case, there are no material issues of fact that remain unresolved and Cuivre River and Ameren Missouri are entitled to judgment on their Motion to Dismiss for Lack of Subject Matter Jurisdiction and for a Determination on the Pleadings as a matter of law because the Commission lacks subject matter jurisdiction to grant the relief requested by Mr. Chaney.

II. Material Facts

The material facts at issue in this matter are not disputed and are listed below.

- 1. Ameren Missouri is an electric utility subject to the jurisdiction of the Missouri Public Service Commission (Commission). § 386.250 RSMo.
- 2. Cuivre River is a rural electric cooperative, organized pursuant to Chapter 394 of the Revised Statutes of Missouri.
- 3. Mr. Chaney is the named Cuivre River member⁴ for the electric account at 1110 St. Theresa Lane in O'Fallon, Missouri.
- 4. Pursuant to Commission rule, Staff of the Commission is a party to this case.⁵
- 5. The Office of Public Counsel (OPC) is also a party to this case by Commission rule,⁶ although OPC has not been active in the case.
- 6. Cuivre River and Ameren Missouri have a Territorial Agreement which allocates between Ameren Missouri and Cuivre River territory in which each may exclusively provide electric service. The Territorial Agreement has been approved by the Commission.⁷
- 7. The property located at 1110 St. Theresa Lane in O'Fallon is in an area for which Ameren Missouri and Cuivre River have entered into a Territorial Agreement. Cuivre River retained the sole right to serve this customer as per the terms of the Territorial Agreement.

- 8. The property located at 1110 St. Theresa Lane in O'Fallon is within the territory allocated to Cuivre River by the Territorial Agreement. A copy of the Territorial Agreement is attached to this Joint Memorandum of Law in Support of Motion to Dismiss as Exhibit 1.
- 9. The current provider of electric service for 1110 St. Theresa Lane is Cuivre River.
- 10. Ameren Missouri and Cuivre River have not entered into any agreement to change which utility could serve the home at 1110 St. Theresa Lane in O'Fallon.
- 11. Missouri's anti-flip-flop statutes govern this request and are found at § 393.106.2 and § 394.315.2 RSMo.

III. Discussion

Mr. Chaney's Application cites his desire to obtain a rebate for the installation of solar power at his home as the basis for his change of supplier request. Commission regulations address conditions under which a change of supplier may be granted. 4 CSR 240-3.140 allows for a change of supplier under certain circumstances. However, this regulation only addresses issues related to a "public interest" determination. The Commission does have to make such a determination prior to ordering a change of supplier, however, before the Commission can turn to the issue of determining whether a request is in the public interest, it must first determine whether there is more than one electric supplier with the right to serve that customer. If there is only one utility with the legal right to serve a particular customer, the Commission has no authority to order a change in electric supplier.

This interpretation comes directly from the language of the statute, which reads:

Once a rural electric cooperative, or its predecessor in interest, lawfully commences supplying retail electric energy to a structure through permanent service facilities, it shall have the right to continue serving such structure, and other suppliers of electrical energy shall not have the right to provide service to the structure except as might be otherwise permitted in the context of municipal annexation, pursuant to section 386.800 and section 394.080, or pursuant to a territorial agreement approved under section 394.312. (¶ 391.315.2 RSMo)

There is no territorial agreement which would allow Ameren Missouri to serve Mr. Chaney and municipal annexation is not at issue either. Accordingly, § 394.315 RSMo. does not aid Mr. Chaney.

This interpretation is consistent with how the courts have interpreted the anti-flip-flop laws (§ 394.315 RSMo., § 394.314 RSMo. and § 393.106 RSMo. – the anti-flip-flop statutes for Electric Cooperatives, Investor Owned Utilities and Municipalities, respectively.) In *Platte-Clay*, the Court of Appeals explained that the Commission's jurisdiction under § 393.106 and § 394.315 is limited to determining "whether a change of suppliers is in the public interest between two electric suppliers *with concomitant rights*" to serve an area. As explained earlier, concomitant rights to serve Mr. Chaney's property do not exist as Cuivre River has the sole right to serve this property.

The bottom line is that the Commission simply has no jurisdiction to apply §393.315 RSMo. because Mr. Chaney has no other supplier to "switch to." If Ameren Missouri and Cuivre River had concomitant rights to serve the property, then Mr. Chaney could ask the Commission to allow it to switch to Ameren Missouri (for reasons other

than rate differential) if the Commission determined the switch was in the public interest.⁹

However, absent those concomitant rights, Mr. Chaney is not entitled to ask for this switch, the Commission cannot grant Mr. Chaney's request, and the Commission thus has only one option as a matter of law: to dismiss this action for lack of subject matter jurisdiction. *See, e.g., State Tax Comm'n v. Admin. Hearing Comm'n*, 641 S.W.2d 69, 72 (Mo. 1982), wherein the Supreme Court ordered the Administrative Hearing Commission to dismiss a case for which it lacked subject matter jurisdiction, explaining that "subject matter jurisdiction concerns 'the nature of the cause of action or the relief sought' and exists only when the tribunal 'has the right to proceed to determine the controversy or question in issue between the parties or grant the relief prayed'" (citations omitted). Like the Administrative Hearing Commission, lacking subject matter jurisdiction, the Commission must dismiss Mr. Chaney's application.

WHEREFORE, Ameren Missouri and Cuivre River respectfully request that the Commission grant summary determination on all issues in this case in favor of the Ameren Missouri and Cuiver River and against Mr. Chaney and find that it cannot grant the relief sought under Missouri law.

⁹ Even if the Commission had jurisdiction to grant Mr. Chaney's request, Ameren Missouri and Cuivre River do not believe that Mr. Chaney's desire to receive a solar rebate is a reason "other than a rate differential" that is in the public interest. Indeed, if Mr. Chaney is permitted to switch suppliers simply to take advantage of the tariffed rebate program, there is no reason any other customer would be disqualified from using to switch electric suppliers.

TERRITORIAL AGREEMENT

THIS AGREEMENT is entered into between Union Electric Company, hereinafter referred to as "Company", and Cuivre River Electric Cooperative, Inc., hereinafter referred to as "Cooperative".

WHEREAS, Company and Cooperative are authorized by law to provide electric service within the State of Missouri, including portions of St. Charles County; and

whereas, the Missouri Legislature has authorized electrical corporations and rural electric cooperatives to enter into written territorial agreements; and

whereas, Company and Cooperative desire to promote the orderly development of the retail electric service system within portions of St. Charles County, Missouri, to avoid wasteful duplication and to minimize disputes which may result in higher costs in serving the public;

NOW, THEREFORE, Company and Cooperative, in consideration of the mutual covenants and agreements herein contained, agree as follows:

- 1. For purposes of this Agreement:
- (a) "Customer" includes any natural person, firm, association, partnership, business trust, public or private corporation, political subdivision or any agency, board, department or bureau of the state or federal government or any other legal entity which has requested or is receiving electric service. Any customer who has requested or is receiving electric

service at one structure shall be a new and different customer at each structure at which electric service has been requested.

- residential, commercial, industrial or other building or a mechanical installation, machinery or apparatus but shall not include customer-owned meter wiring. "Structure" shall include contiguous additions to and expansions of previously existing structures and replacements of previously existing structures and replacements are used for the same purposes and have basically the same power usage characteristics as the original structure.
- (c) "Company" shall mean Union Electric Company and any subsidiary or other corporate entity owned or controlled by Union Electric Company.
- (d) "Cooperative" shall mean Cuivre River Electric Cooperative, Inc. and any subsidiary or other corporate entity owned and controlled by Cuivre River Electric Cooperative, Inc.
- (e) "New Structure" shall mean any structure which did not receive electric energy from either party prior to the effective date of this Agreement.
- 2. From the effective date of this Agreement, as between the parties hereto, each shall have the exclusive right to furnish electric service to all new structures located within its respective electric service area described in paragraphs 3 and 4 of this Agreement, regardless of the size of the load or the characteristics of the tustomers' requirements. Except as

provided expressly herein, neither party may furnish, make available, render or extend electric service to structures or for use within the electric service area of the other party, either directly, indirectly or through a subsidiary corporation or other entity controlled by the party. Each party shall have the right to continue to serve those structures located in the electric service area of the other party which it is serving on the effective date of this Agreement. In addition, each party shall have the right to serve new structures in multi-tract contiguous development areas identified on Exhibit 4, which are within either party's service area as defined in paragraph 3 and 4 of this agreement. Exhibit 4 is attached hereto and made a part hereof. Cooperative's right to serve new structures within such multi-tract development areas located within the Company's electric service area defined in paragraph 3 shall cease if and when such development areas are annexed into the city limits of a city with a population in excess of 1500 inhabitants unless the Cooperative has installed primary distribution facilities/ designed for and capable of providing service to such structures prior to annexation!

3. The electric service area of Company under this Agreement shall be that portion of St. Charles County as described by metes and bounds in Exhibit 1 to this Agreement excluding those portions of St. Charles County described by metes and bounds in Exhibit 3 and as substantially illustrated by the map marked Exhibit 2 to the Agreement, all exhibits being

incorporated herein by reference and made a part of this Agreement as if fully set out verbatim.

- 4. The electric service area of Cooperative under this Agreement shall be those portions of St. Charles County as described by metes and bounds in Exhibit 3 to this Agreement and as substantially illustrated by the map marked Exhibit 2 to this Agreement, both exhibits being incorporated herein by reference and made a part of this Agreement as if fully set out verbatim.
- The parties to this agreement reserve for purposes of a future territorial agreement a portion of St. Charles county, more specifically described as sections 6, 7, 18, 19, 30 and 31 of Township 46 North, Range 1 East; sections 30 and 31 of Township 47 North, Range 1 East; such portion of section 19 of Township 47 North, Range 1 East in St. Charles county, Missouri, as is south of the center line of U.S. Highway 70; and such portion of section 6 of Township 45 North, Range 1 East in St. Charles county, Missouri, as is north of State Highway T and State Highway D. Both parties shall have the right to serve new structures in such portion of St. Charles county as they would have under the principles of law of the state of Missouri. Company shall have the additional right to waive in whole or in part any charge for any service, including wiring, piping, appliances or equipment, required by its tariffs on file with the Missouri Public Service Commission or by the Commission's Promotional Practice Rule, 4 CSR 240-14.010 et seq., to new structures located within such portion of St. Charles county as

it deems justified, the Commission's Promotional Practices Rule notwithstanding. Cooperative hereby waives any right it may have to file a Complaint either with the Commission or a court alleging the Company's violation of the Commission's Promotional Practices Rule within such portion of St. Charles county.

- Agreement shall be the geographical location at which electric power and energy is used, regardless of the point of delivery.

 The first owner of a new structure located on or crossed by any line described in paragraphs 3 and 4 dividing the electric service territories of the parties shall be permitted to choose either party for permanent electric service provided that the customer's meter is installed within that supplier's service area, and thereafter that supplier shall exclusively serve that structure.
- 7. The parties may agree on a case-by-case basis to allow structures to receive service from one party though the structure is located in the electric service area of the other. Such agreements shall be in writing and approved by both parties.
- 8. Company and Cooperative agree to undertake all actions reasonably necessary to implement this Agreement. Company and Cooperative will cooperate in presenting a joint application showing this Agreement to be in the public interest. Company and Cooperative will share equally in the costs assessed by the Public Service Commission for seeking of administrative approval

of this Agreement. All other costs will be borne by the respective party incurring the costs.

- 9. Except as expressly provided herein, neither the boundaries described by this Agreement nor any term of this Agreement may be modified, repealed or changed except by a writing mutually approved by the respective parties and by the Missburi Public Service Commission.
- 5. This Agreement shall be binding on the parties and all subsidiaries, successors, assigns and corporate parents or affiliates of Company and Cooperative.
- 10. This Agreement shall become effective upon approval by the Missouri Public Service Commission pursuant to Section 394.312 RSMO. and the Boards of Directors of the parties. The term of this Agreement shall be perpetual. Performance of the parties is contingent upon all of the following having occurred no later than March 31, 1993:
- (a) All required approvals of the Cooperative's Board of Directors.
- (b) Approval of the transaction by the Public Service Commission of Missouri, including but not limited to the following:
 - (1) a finding that this agreement shall not impair the Company's certificates of convenience and necessity in any respect within St. Charles county.
 - (2) an order granting the Company the authority to make offers described in paragraph 5 to potential customers.

Such order may not limit Company's authority to exercise such right upon condition of prior Commission approval of such offer. However, recovery of the cost of extending service to the new structure may be conditioned upon a finding by the Commission based upon evidence submitted by the Company that it will receive a benefit by providing service to the new structure and that such service will benefit its existing customers.

- (c) Approval of the transaction, if necessary, to the extent of its jurisdiction, by the Federal Energy Regulatory Commission.
- territories outside of the area covered by this Agreement.

 Within the service areas outside of that covered by this

 Agreement, each party will continue to operate without regard to this Agreement. The principles of law, rules and regulations applicable to the business of retail sales of electricity shall apply without regard to this Agreement.
- 12. As a part of this Agreement, the parties agree that all claims pending in the lawsuits styled <u>Union Electric Company v.</u>

 <u>Cuivre River Electric Cooperative</u> and <u>Union Electric v. SSM</u>

 <u>Health Care System</u>, Case No. CV190-5138CC, and <u>Union Electric v.</u>

 <u>Cuivre River Electric Cooperative</u>, Case No. CV190-5239CC, shall be dismissed with prejudice, each party to bear their own costs.
- 13. This Agreement shall in no way affect either party's right to construct such electric distribution and transmission

facilities within the designated electric service area of the other as that party deems necessary, appropriate or convenient to provide electric service to its customers under the terms of this Agreement or otherwise.

14. This contract constitutes the entire agreement between the parties relating to the allocation of service rights in the territory described herein. If the Public Service Commission of Missouri does not approve the provisions of this Agreement, then it shall be nullified and of no legal effect between the parties. Further, if any part of this Agreement is declared invalid or void by a Court or agency of competent jurisdiction, then the whole Agreement shall be deemed invalid or void.

IN WITNESS WHEREOF, the parties have executed this Agreement this 30th day of October, 1992.

Beginning at a point on the west line of Section 20, Township 47 North, Range 1 East, St. Charles County, Missouri, said point being on the center line of U.S. Interstate 70; thence in an easterly direction along the center line of said Interstate 70, a distance of 26 miles, more or less, to a point in the center of the Missouri River; thence in a southerly and westerly direction along and with the meandering of the center of said Missouri River, a distance of 13.5 miles, more or less, to the center of U.S. Highway No. 40; thence in a northwesterly direction along the center of said Highway No. 40, a distance of 6.5 miles, more or less, to a point in Section 13, Township 46 North, Range 2 East, St. Charles County, Missouri, said point also being on the easterly extension of the southerly line of Survey No. 297, Township 46 North, Range 2 East, St. Charles County, Missouri; thence in a westerly direction along the easterly extension of the southerly line of said Survey No. 297 and along the southerly line of said Survey No. 297, and along the westerly extension of the southerly line of said Survey No. 297, a distance of 3 miles, more or less, to a point on the east line of Section 16, Township 46 North, Range 2 East, St. Charles County, Missouri; thence southerly along the east line of Sections 16, 21, 28, and 33, Township 46 North, Range 2 East, St. Charles County, Missouri, to a point in the center of Missouri State Route D; thence in a westerly direction along the center of said Route D, a distance of 8.5 miles, more or less, to a point on the west line of Section 5, Township 45 North, Range 1 East, St. Charles County,

Missouri; thence northerly along the west line of said Section 5, a distance of .5 miles, more or less, to the northwest corner of said Section 5; thence easterly along the north line of said Section 5 to the southwest corner of Section 32, Township 46 North, Range 1 East, St. Charles County, Missouri; thence northerly along the west line of Sections 32, 29, 20, 17, 8, and 5, of Township 46 North, Range 1 East, St. Charles County, Missouri, to the northwest corner of said Section 5, said point also being the southwest corner of Section 32, Township 47 North, Range 1 East, St. Charles County, Missouri; thence northerly along the west line of Sections 32, 29, and 20, of Township 47 North, Range 1 East, St. Charles County, Missouri, a distance of 2.25 miles, more or less, to the point of beginning. Excepting therefrom two tracts designated as Cuivre River Electric Co-op territory, said tracts being more particularly described in Exhibit Three.
