Enclosed for filing with the Commission in the above-referenced case are an original and eight copies of the Highly Confidential ("HC") version of Southwestern Bell Telephone Company's ("SWBT's) Quarterly Monitoring Report. This Report is Highly Confidential in its entirety as it: (1) contains information related directly to certain specific wholesale customers of SWBT; (2) provides market share information concerning SWBT's affiliate ("SBC Advanced Solutions Inc.") and other wholesale customers of SWBT; and (3) contains network information of SWBT. Please note that SWBT's Quarterly Monitoring Report that was filed on October 10, 2000, contained data regarding the months of June, July, August, and September, 2000. Additionally, SWBT's Supplement to its Prior Quarterly Monitoring Reports that was filed on November 29. 2000, included data for June, July, August, September, and October. It is our understanding that SWBT's Quarterly Monitoring Report is for the Commission's use only. SWBT has, therefore, not provided it to the other parties in the above-referenced case.
