

**MOTION TO EXTEND TIME FOR INTERVENTION**

Come now the Cities of Warrensburg, O'Fallon and Weldon Spring, the ("Cities") pursuant to 4CSR 240-2.080 and for their Motion to Extend Time for Intervention state:

1. On October 15, 1999, Missouri-American Water Company submitted to the Commission proposed tariff sheets intended to implement a general rate increase for water and sewer service provided to customers in the Missouri service area of the Company. The proposed tariffs bear a requested effective date of November 15, 1999. The proposed water service tariffs are designed to produce an annual increase of approximately 53.97 percent (\$16,446,277) in the Company's revenues.

2. On October 28, 1999, the Commission issued its Suspension Order and Notice setting a date for interested parties to intervene no later than November 17, 1999. The Commission ordered that copies of its Order be sent to the Mayor of each City, the County Commission of each County of the Company's service area.

3. On or about November 16, 1999, the Cities filed their Application to Intervene.

4. The Cities have been advised that these are other municipalities and counties served by Missouri-American Water Company ("MAWC") who are interested in intervening but are still in the process of reviewing the proposed new rates and the implications of Single Tariff Pricing.

5. The Intervening Cities have been requested by several of the other cities to request additional time until December 7, 1999 in which to intervene.

6. No party would be prejudiced by such an extension of time in that the first scheduled event is an early prehearing conference set for December 14, 1999.

WHEREFORE, the Cities of Warrensburg, O'Fallon and Weldon Spring, respectfully request the Commission to grant its Motion to Extend Time for Intervention to December 7, 1999.
