### MEMORANDUM OF PREHEARING CONFERENCE

Appearing on behalf of DIECA Communications, Inc were Mr. Mark Johnson, Esq. and Mr. Todd McGuire, Esq. Appearing on behalf of Southwestern Bell Telephone Company were Ms. Katherine Swaller, Esq., Mr. Paul Lane, Esq., Mr. Tom Hughes, and Mr. David Osborn.

The following summarizes the matters resolved during the course of the prehearing conference:

- 1. By agreement of the parties and with the consent of Judge Thornburg, the hearing will begin at 9:00 a.m. on February 8, 2000, and continue on February 9<sup>th</sup> and 15<sup>th</sup>, if necessary.
- 2. By agreement of the parties and with the consent of Judge Thornburg, DIECA Communications, Inc. and Southwestern Bell Telephone Company will submit a joint statement of issues to be resolved by arbitration on January 5, 2000. Recognizing that negotiations

between the parties are ongoing, this statement of issues will be supplemented by the parties if additional issues are resolved prior to the hearing.

3. Judge Thornburg will issue an Order adopting the proposed procedural schedule submitted by the parties on December 20, 1999, as modified by paragraphs 1 and 2 above.
