<b>Description</b>	1. Is it Staff's belief that the new Pratt & Whitney FT8 TwinPacs will require no maintenance or inspections in the future? 2. What level of annual Operation & Maintenance expense does Staff believe is appropriate for Pratt & Whitney FT8's? 3. What level of Operation & Maintenance expense is included in Staff's direct testimony for the FT8's?
<b>Response</b>	The Staff believes that the new Pratt & Whitney FT8 TwinPacs will require maintenance and inspections. Due to the lack of experience with the new Pratt & Whitney FT8 TwinPacs, since the units have only been in service since April of 2003, the Staff believes the level of ongoing operation and maintenance (O&M) expense is unknown. The Staff has made no specific adjustment; therefore, it has included the level of O&M expense that was actually incurred during the test year in its direct filing for the FT8`s.
