- 1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission grant approval of the Interconnection and Reciprocal Compensation Agreement between Le-Ru Telephone Company and Nextel West Corp. (Nextel) (Agreement) filed by Le-Ru Telephone Company under the provisions of the federal Telecommunications Act of 1996.
- 2. The terms of the Agreement do not discriminate against telecommunications carriers not a party to the Agreement and are not against the public interest, convenience or necessity. WHEREFORE, because the terms of the Agreement satisfy the standard set forth in 47 U.S.C. §252(e), Staff recommends the Commission approve the Agreement and

direct the parties to submit any future modifications or amendments to the Agreement to the Commission for approval.
