

## MAPLEWOOD INITIAL CUSTOMER NOTICE

August 11, 2009

Aqua Missouri, Inc. (Aqua) submitted a request to the Missouri Public Service Commission (Commission) on July 15, 2009 for increases in its annual water and sewer operating revenues for Maplewood. The primary reasons for the water increase are investment in upgrades to a well house, new meters and fencing, and increased expenses over the past two years. The primary reasons for the sewer increase are sewer main replacement and fencing, and increased expenses over the past two years.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual water operating revenues of \$40,900 (27.5 percent) and its sewer operating revenues of \$41,100 (approximately 34.6 percent). At the end of this notice is a table that compares the Company's current residential customer rates and the proposed residential rates.

To provide comments regarding the Company's revenue increase request, or comments regarding any recent service-related problems, please contact the Commission Staff and/or the Office of the Public Counsel (OPC) ***within 30 days of the date of this notice***. Your comments should include reference to case numbers WR-2010-0027 and SR-2010-0026. The Commission Staff and the OPC will review all customer comments submitted in response to this notice. All comments will be filed in the official case file for review by the Commissioners.
