
1. Exhibit 45 attached hereto is a 1-page exhibit which breaks out MAWC’s Rate A customers by class (i.e., Residential, Small Commercial, and Other Public Authority (OPA)). This Exhibit also indicates the number of Rate A customers, by class, served by a 5/8 inch meter.

2. Exhibit 46 attached hereto is a 5-page exhibit, similar in format to Exhibit 136, with the monthly meter charge for a 5/8 inch meter set at \$8.00, but holding customer charges for all other meter sizes constant (i.e., at the rates contained in Exhibit 136).

3. Exhibit 47 attached hereto is a 5-page exhibit which sets the monthly meter charge for a 5/8 inch meter at \$9.00, but holding customer charges for all other meter sizes constant.

**WHEREFORE**, MAWC submits these exhibits in response to the Commission’s Order Directing Filing of additional exhibits and requests it issue such further orders as are appropriate in the circumstances.
