
RESPONSE TO STAFF’S RECOMMENDATION

COME NOW Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, CenturyTel of Missouri, LLC, Spectra Communications Group, LLC d/b/a CenturyTel, Windstream Missouri, Inc. and the Missouri Independent Telephone Company Group¹ (collectively referred to herein as “the ILEC Intervenors”), and provide this response to the Missouri Public Service Commission Staff’s Recommendation filed April 25, 2007. Staff observed that United Way of Greater St. Louis, Inc. (“UWGSL”) had filed a revised proposed list of exchanges, and recommended that the Commission grant UWGSL’s Application for Authority as an Information and Referral Provider, as revised. The ILEC Intervenors have no objection to the Commission’s granting UWGSL’s Application.


