On November 12, 2009, the Missouri Public Service Commission (Commission) issued its Order Granting Certificate of Convenience and Necessity (Order) in Case No. GA-2010-0012, the Missouri Gas Utility, Inc. (MGU or Company) Application for Certificate of Convenience and Necessity (CCN). This Order approved a new and expanded service area for MGU.

The Company filed tariff sheets on December 18, 2009, to comply with the Order. MGU also filed a number of Tariff Sheets to change the header information and correct typos that were present. MGU's change of the header information will simplify future tariff filings and decrease the number of tariff sheets MGU must file for any system expansion. MGU's proposed change from individually listing the counties in its tariff heading to reflect a Northern Service Area and a Southern Service Area will reduce the number of tariff sheets the Company must file when expanding its service territories.

The Staff has reviewed MGU's December 18, 2009 tariff filing, and is of the opinion that these sheets are in compliance with the Commission's Order and will simplify future MGE tariff filings for expansions of its service territories. Therefore, Staff recommends approval of the following tariff sheets filed on December 18, 2009, with an effective date of January 17, 2010:
