SUBJECT: Staff Recommendation On Missouri Gas Energy's Tariff Sheets Filed to Comply with the
Commission's Report And Order

DATE: September 13, 2010

On August 31, 2010, the Missouri Public Service Commission (Commission) issued an Order that rejected the original transportation tariff sheets filed by Missouri Gas Energy (MGE or Company).

On September 1, 2010, the Commission issued its Report and Order (Order) in Case No. GT-2010-0261. This ORDER APPROVING STIPULATION AND AGREEMENT (Order) revises the transportation tariff of MGE. The Order also directed MGE to file tariff sheets expeditiously to accommodate the September 15, 2010 effective date contemplated by the Stipulation.

On September 8, 2010, MGE filed tariff sheets to comply with the Order. On September 10, 2010, MGE filed substitute tariff sheets. Which were related to typographical errors and omissions that reflect the Commission's approval of the Stipulation.

In its letter of transmittal accompanying the September 8, 2010 and the substitute September 10, 2010 compliance filings, MGE is requesting an effective date of September 15, 2010, which would be less than the standard 30-day period, but which complies with the effective date directed in the Commission's Order.

The Commission's Energy Department - Tariffs/Rate Design Staff (Staff) has reviewed each of the tariff sheets, as filed by MGE on September 8, 2010, as substituted on September 10, 2010, and is of the opinion that these sheets are in compliance with the Commission's Order. Staff is also of the opinion that good cause for approval of these tariff sheets on less than thirty days notice is demonstrated by the Commission's Order. Therefore, Staff recommends that the set of tariff sheets designated P.S.C. MO. No. 1, September 8, 2010, and as substituted on September 10, 2010, be approved and to become effective on and after September 15, 2010.


