ORDER RECOGNIZING NAME CHANGE

Issue Date: July 12, 2023

Effective Date: July 14, 2023

On June 30, 2023, Embarq Missouri, Inc., d/b/a CenturyLink submitted a letter and an accompanying tariff, advising that it has changed its name to Brightspeed of West Missouri, LLC. The tariff bears an effective date of July 14, 2023.

On July 7, 2023, the Staff of the Commission (Staff) filed a recommendation indicating the company had complied with all statutory and regulatory requirements for changing its name. Staff recommended that the Commission recognize the name change. The Commission will do so.

To allow Brightspeed of West Missouri, LLC to implement the name change expediently, the Commission finds it reasonable to allow this order to become effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the name change of Embarq Missouri, Inc. d/b/a Century Link to Brightspeed of West Missouri, LLC.
2. This order shall become effective on July 14, 2023.
3. This file shall be closed on July 15, 2023.
