On December 22, 2017, Charter Fiberlink-Missouri, LLC, pursuant to §392.550 and §392.611, RSMo 2016, filed an application to amend its registration to provide basic local, non-switched local, and interexchange telecommunications service in the State of Missouri to add the following service areas as identified by each exchange, in whole or in part, of a local exchange company: Kingdom Telephone Co. Exchange- Auxvasse; Farber Telephone Co. Exchange- Farber; Chariton Valley Telephone Co. Exchange- Huntsville; New Florence Telephone Co. Exchange- New Florence; Windstream Missouri, Inc. Exchange- Martinsburg; Fidelity Telephone Co. Exchange- Sullivan; and Steelville Telephone Exchange- Steelville.

The Commission has reviewed the application filed by the company and finds that it and the attached affidavit comply with the filing requirements set forth in §392.550, RSMo 2016.

THE COMMISSION ORDERS THAT:

1. Charter Fiberlink-Missouri, LLC's amendment to its registration to provide basic local, non-switched local, and interexchange telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above is granted.
2. This Order shall become effective on January 15, 2018.
3. This case may be closed on January 16, 2018.
