## **LATE-FILED NOTICE OF COMPLIANCE**

COMES NOW Aquila, Inc. d/b/a Aquila Networks-MPS and Aquila Network L&P, by and through counsel, and states to the Missouri Public Service Commission ("Commission") as follows:

1. Pursuant to an Order of Rulemaking in Case No. EX-2008-0232,<sup>1</sup> the Commission adopted a new rule entitled Electrical Corporation Vegetation Management Standards and Reporting Requirements which is codified at 4 CSR 240-23.030. Subsection (4)(C) of that rule provides, in pertinent part, as follow:

Each electrical corporation shall file a copy of its vegetation management standards, guidelines and procedures at the commission by July 1, 2008, with verification by affidavit of an officer who has knowledge of the matters stated therein. If an electrical corporation makes a change in its vegetation management standards, guidelines or procedures, it shall file a copy of the change at the commission no later than thirty (30) days prior to implementing the change, with verification by affidavit of an officer who has knowledge of the matters stated therein.

2. Pursuant to the Commission directive set forth above, Aquila submits herewith documentation concerning its Missouri Line Clearance and Vegetation Management Standards and related information. Copies of this
