Dear Secretary Dippell:

Pursuant to 20 CSR 4240-28.011, MCImetro Access Transmission Services Corp. ("MCImetro Corp.") hereby notifies the Commission that it has changed its name to MCImetro Access Transmission Services LLC ("MCImetro LLC"). The Company respectfully requests that the Commission issue an updated certificate reflecting the new name. MCImetro Corp. provides competitive local exchange service pursuant to the Order in Case No. TA-96-355, dated February 21, 1997. This change does not affect the rates, terms or conditions of services provided to MCImetro Corp.'s customers. All EFIS contacts for MCImetro LLC will remain the same.

The name change took place nationally in 2021 and customers were notified via bill insert in the month of May, 2021, a copy of which is attached. Due to unforeseen delays in obtaining a Certificate of Tax Clearance from the Missouri Department of Revenue, a necessary predicate to completing the name change through the Missouri Secretary of State, the name change request could not be filed with the Secretary of State until May of this year. Documentation that the new name is now registered with the Secretary of State is also attached.

MCImetro Corp. is also providing a copy of its updated tariff pages reflecting the name change.
