**JOINTLY PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri or the Company), the Staff of the Missouri Public Service Commission (Staff), the Office of the Public Counsel (OPC), Laclede Gas Company (Laclede) and Consumers Council of Missouri and submit this Jointly Proposed Procedural Schedule, and in support thereof, state as follows:

1. During the Prehearing Conference held on January 24, 2014, the Regulatory Law Judge presiding requested the parties file a proposed procedural schedule. The parties have reached agreement on a proposed procedural schedule, which is set forth in paragraph 2 below and also request the Missouri Public Service Commission (Commission) adopt the related procedural items which have also been agreed upon, as reflected in paragraph 3 below.

2. The parties do not believe it appropriate to propose a procedural schedule with testimony and hearing dates at this time. Instead, the parties would like to continue discovery and schedule a settlement conference to see if a resolution that satisfies all parties can be reached. Accordingly, the parties propose the following limited procedural schedule at this time:

Settlement Conference	February 21, 2014 at 10 am
Staff and other party Recommendation	February 28, 2014

If there is a settlement of the issues in this case, no party shall be required to file a recommendation on February 28, 2014. The parties reserve their right to request a hearing in this case if necessary.

3. In addition, the parties agree that File Nos. ET-2014-0076 and GE-2014-0180 contain the same issues and should be consolidated for all purposes. Staff has recently filed new DRs in ET-2014-0076, and therefore the parties request that both cases be consolidated into File No. ET-2014-0076.

4. Ameren Missouri agrees to voluntarily suspend the tariffs for 60 days beyond the current effective date of February 7, 2014, so that the above set forth procedural schedule can be completed.

5. The Consumers Council of Missouri, although not a signatory to this pleading, has informed Ameren Missouri's counsel that it does not oppose this proposed procedural schedule.

WHEREFORE, the parties request the Missouri Public Service Commission approve the procedural schedule and other matters as set forth above.
