JOINT MOTION TO MODIFY PROCEDURAL SCHEDULE

COME NOW KCP&L Greater Missouri Operations Company ("GMO"), the Staff of the Missouri Public Service Commission ("Staff"), the Office of the Public Counsel ("OPC"), Missouri Department of Natural Resources ("MDNR"), Missouri Industrial Energy Consumers ("MIEC"), Sierra Club, Natural Resources Defense Council ("NRDC"), Renew Missouri, Sam's East, Inc. ("Sam's Club"), Wal-Mart Stores, Inc. ("Wal-Mart") (collectively, the "Parties"), and files this *Joint Motion to Modify Procedural Schedule* with the Missouri Public Service Commission ("Commission") and states as follows:

- 1. On May 10, 2012, the Commission issued an *Order Regarding Motion to Reschedule Evidentiary Hearing*, by which the Commission ordered the Parties to suggest alternative hearing dates. The Parties hereby recommend the Commission schedule June 18, 2012 through June 20, and June 25, 2012, for the evidentiary hearing in this matter. (The June 25th date may be needed to accommodate the schedule of a Staff witness.)
- 2. On May 14, 2012, the Commission issued an *Order Granting Joint Motion for Extension of Time to File a List of Issues and Statement of Positions*, by which the Commission ordered that the List of Issues be filed no later than May 31, 2012 and the Statements of Position be filed no later than June 6, 2012.

3. Since the evidentiary hearings will need to be rescheduled to a later date, the Parties respectfully request that the dates for filing the Joint List of Issues, Order of Witnesses and Order of Cross Examination be extended to June 6, 2012, and for the date for filing the Statements of Positions be extended to June 13, 2012. If the Parties cannot reach an agreement on the list of issues, then the Parties will file separate issues lists for the Commission's consideration.

WHEREFORE, GMO files this *Motion* requesting the Commission schedule the evidentiary hearings from June 18 through June 20, and June 25, 2012, and extend the dates by which the Parties are to file a joint List of Issues, Position Statements, and Evidentiary Hearing to the dates suggested by the Parties in this *Motion*.
