The purpose of this filing is to withdraw certain tariff sheets originally included in Tracking No. YS-2020-0212. On June 4, 2020, Elm Hills Utility Operating Company, Inc. ("Elm Hills") filed new and revised tariff sheets in compliance with the Commission's *Order Granting Transfer of Assets and Granting Certificate of Convenience and Necessity* in File No. SM-2020-0146. On June 8, 2020, after discussions with Staff, Elm Hills filed substitute tariff sheets correcting the map of service area and legal description of service area for Private Garden and Prairie Field. The substitute tariff sheets filed June 8, 2020 include: P.S.C. MO No. 2, 3rd Revised Sheet No. 1, canceling P.S.C. MO No. 2, 2nd Revised Sheet No. 1; P.S.C. MO No. 2, Original Sheet 2I; and P.S.C. MO No. 2, Original Sheet 3H.

The corrected substitute tariff sheets eliminate the need for previously filed sheets P.S.C. MO No. 2 Original Sheets Nos. 3H-2 and 3H-3. Therefore, Elm Hills hereby withdraws the following two original sheets filed on June 4, 2020:

P.S.C. MO No. 2 Original Sheet No. 3H-3.
