Dear Ms. Dale:

The purpose of this filing is to change the name of the issuing entity of Qwest Communications Corporation's ("QCC") Missouri P.S.C. Tariff No. 4. The name of the new entity is Qwest Communications Company, LLC ("QCC LLC"). Pursuant to 4 CSR 240-2.060(5), this filing contains an original Adoption Notice sheet by which QCC LLC adopts the QCC Missouri P.S.C. Tariff No. 4 in its entirety, as well as a revised title page showing the change in name. With this filing QCC is making no changes to processes, offerings, rates, terms or conditions, and the name change will be seamless and transparent to, and have no effect on, QCC customers.

In a separate letter filed via EFIS today, November 4, 2008, Qwest Communications Corporation provides notice of the change in name to Qwest Communications Corporation, LLC, due to its conversion from a corporation to a limited liability company, pursuant to Delaware law. In order to provide reference within that letter to this and two other QCC Missouri tariff name changes, also filed via EFIS today, all three related tariff filings precede the filing of the notice letter.

The proposed effective date for this change is January 2, 2009.
