Dear Commissioner:

This letter is to notify the municipality that on February 13, 2009, Mediacom Southeast LLC Has transferred the video service authorization issued to it by the Missouri Public Service Commission on March 8, 2008, to MCC Missouri LLC. MCC Missouri, like Mediacom Southeast LLC, is a wholly owned operating subsidiary of Mediacom Communications Corporation that also manages both companies. This transfer occurred simply to align Mediacom's assets to make it simpler to operate. Thus instead of two subsidiaries operating in Missouri there will be only one. This transfer of the video service authorization, however, will have no impact on day to day operations of the cable system serving your community. The same personnel will be running the cable systems as before.

The transfer of the state issued video service authorization by notice only to local communities and the Missouri Public Service Commission is permitted under Section 67.2701 of the Missouri Revised Statutes that states that "neither the public service commission nor any political subdivision shall have any authority to review or require approval of any transfer of a video service authorization...".
