#### ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 24, 2000, EqualNet Corporation ("EqualNet"), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. EqualNet stated that it was unable to file its report timely due to inadvertent difficulties meeting the filing time. No objections to EqualNet's motion were received.

The Commission finds that good cause exists to permit filing of EqualNet's annual report out of time, and the Commission will grant EqualNet's motion for leave to file its annual report out of time.

#### IT IS THEREFORE ORDERED:

- 1. That EqualNet Corporation's May 24, 2000, motion requesting permission to file its annual report out of time is granted, and the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of EqualNet Corporation's annual report on May 24, 2000, is approved.
  - 2. That this order shall become effective on June 9, 2000.

3. That this case may be closed on June 12, 2000.
