

**MOTION FOR LEAVE
TO FILE ANNUAL REPORT OUT OF TIME**

Comes now NEXTLINK Long Distance Services, Inc. (NEXTLINK), by and through counsel, and pursuant to 4 CSR 240-10.080(8) respectfully requests the Commission for leave to file its 1999 Annual Report to the Commission as an Interexchange Telecommunications Company (the Annual Report) out of time. In support thereof, NEXTLINK states the following to the Commission:

1. The Annual Report was due to be filed on April 17, 2000,¹ and NEXTLINK attempted to file the Annual Report on or about April 19, 2000. The filing was rejected due to the absence of a formal request for leave to file out of time over the signature of the Company's attorneys.

2. NEXTLINK missed the deadline for filing the Annual Report through honest but excusable inadvertence. The late filing was not done intentionally or designed to purposefully violate the rules of the Commission. Allowing the late filing of the Annual Report would not be detrimental to the public interest.

WHEREFORE, NEXTLINK respectfully requests the Commission to allow NEXTLINK to file its Annual Report out of time.

¹April 15 fell on a Saturday this year and accordingly, the due date for filing the Annual Report was the next business day, or Monday, April 17, 2000.

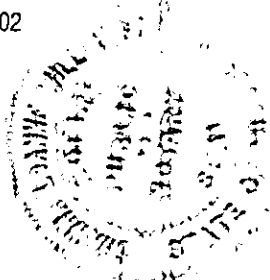


