#### <u>Complaint</u>

COMES NOW the Director of Manufactured Housing and Modular Units Program of the Missouri Public Service Commission by and through the Office of Staff Counsel of the Missouri Public Service Commission's ("Commission"), pursuant to Section 700.100, RSMo 2000<sup>1</sup> and for his Complaint against Burkhart Mobile Homes, Inc., states as follows:

#### **Introduction**

1. This Complaint concerns Burkhart Mobile Homes, Inc.'s, ("Respondent" or "Burkhart") violation of certain Commission rules and Missouri statutes, by failing to renew its dealer's license and continuing to sell or offer for sale manufactured homes and modular units with an expired dealer's license.

#### **COMPLAINANT**

2. Complainant is the Director of Manufactured Housing and Modular Unit Program of the Missouri Public Service Commission ("Director"), Commission Rule 4 CSR 240-123.020 delegates to the Director all of the Commission's powers pertaining to manufactured homes and

modular units under Chapter 700 RSMo, except the powers to revoke, deny, refuse to renew, or place on probation, a registration under Section 700.090, which are retained by the Commission.

#### RESPONDENT

- 3. Respondent Burkhart Mobile Homes, Inc., is located at 8700 E. 70 Highway, in the City of Kansas City, County of Jackson, State of Missouri.
- 4. Burkhart was administratively dissolved by the Missouri Secretary of State's Office, as of August 25, 2010, for failure to file a correct and current annual report. See Attachment 1.

#### **JURISDICTION**

- 5. Burkhart is in the business of selling or offering for sale both new and used manufactured homes and modular units.
- 6. As such, Burkhart qualifies as a manufactured home "Dealer," as defined in Section 700.010(4), and is therefore subject to the jurisdiction of the Commission under Section 700.040 RSMo 2000.

#### **FACTS COMMON TO ALL COUNTS**

- 7. Burkhart filed an application to renew its' *Manufactured Home Modular Unit Certificate of Dealer Registration* with the Commission on January 25, 2010. *See*Attachment 2.
- 8. On January 28, 2010, the Commission Staff notified Burkhart, by mail and facsimile (see attachment 3), of the insufficiencies of its application, including:
- (a) Failure to provide a Certificate of Good Standing from the Secretary of State of the State of Missouri; and

- (b) Failure to provide a current Certificate of No Tax Due.<sup>2</sup>
- 9. At some point in time, Burkhart provided a Certificate of Good Standing to the Director, but remained delinquent regarding the Certificate of No Tax Due.
- 10. On May 20, 2010, Staff field inspector Ronnie Mann inspected Burkhart's Kansas City lot, and red-tagged three homes, referred to herein as the "Champion I," the "Clayton," and the "Redman." See Attachments 4 and 5.
- 11. On or about June 14, 2010, Burkhart entered into a purchase agreement with William A. and Wanda M. Smith, of Lansing, Kansas, for the purchase of the red-tagged Champion I home. *See* Attachment 6.
- 12. On August 25, 2010, the Missouri Secretary of State's Office administratively dissolved Burkhart Mobile Homes, Inc., for failure to file a correct and current annual report, effectively revoking the Company's Certificate of Good Standing. *See* Attachment 1.
- 13. On September 10, 2010, during a site inspection of a home owned by Milton Kutzil, of East Rhonda Drive, Excelsior Springs, Missouri, field inspector Mr. Ronnie Mann found that the home being inspected was the red-tagged Clayton home from the Burkhart lot. *See* Attachment 7.
- 14. On November 23, Mr. Mann again inspected the lot and red-tagged a fourth new home, referred to herein as the "Champion II" home, that had just been added to Burkhart's inventory.

- 15. On December 30, 2010, Mr. Ronnie Mann did a site inspection of the home of John R. Wilder at 4901 S. Valley View Lot #76, Blue Springs, Missouri. Mr. Mann discovered that the Wilder's home was the Champion II home that was red-tagged on November 23, 2010. See Attachment 9. A purchase agreement shows this home was sold to the Wilder's on August 9, 2010. See Attachment 10.
- 16. In January 2011, Mr. Delbert Scott contacted the Director to inform him of problems he was having with Burkhart. Mr. Scott stated that he had purchased a used home from Burkhart in September 2010 which had never been delivered. Mr. Scott also stated that Burkhart covered that sale with a different used home, which was accepted by Scott, and memorialized in a purchase agreement dated January 7, 2011. See Attachment 11.
- 17. In total, Burkhart sold or offered for sale three new homes and one used home without a valid registration.

## COUNT I 700.045(1) MISDEMEANOR SALE WITHOUT REGISTRATION

- 18. The Director re-alleges and incorporates herein the allegations and information contained in paragraphs 1-17.
- 19. Section 700.045 RSMo 2000 states, "It shall be a misdemeanor: (1) For a manufacturer or dealer to manufacture, rent, lease, sell or offer to sell any manufactured home or modular unit after January 1, 1977, unless there is in effect a registration with the commission."
- 20. Burkhart has failed to provide a current *Certificate of No Tax Due*, with the Director, a document necessary for renewal of registration.
- 21. As of August 25, 2010, Burkhart no longer holds a *Certificate of Good Standing* in the State of Missouri a document necessary for renewal of registration.

22. Burkhart sold three new manufactured homes, and one used manufactured home, while not properly registered with the Commission.

## COUNT II REGISTRATION AND RENEWAL – REFUSAL TO RENEW 700.100.3(3) AND (4)

- 23. The Director re-alleges and incorporates herein the allegations and information contained in paragraphs 1-22.
- 24. Section 700.100.1 RSMo, states that the commission may, "...refuse to renew the registration of any person who fails to comply with the provisions of sections 700.010 to 700.115..." Section 700.100.3 RSMo gives grounds for the suspension, revocation or placing on probation of a manufacturer's or dealer's registration: (1) If required, failure to comply with the provisions of section 301.280; (2) Failing to be in compliance with the provisions of section 700.090; (3) If a corporation, failing to file all franchise or sales tax forms required by Missouri law; (4) Engaging in any conduct which constitutes a violation of the provisions of section 407.020;
- 25. Burkhart has violated 700.100.3(3) in that Burkhart has failed to provide the Certificate of No Tax Due with its registration as required by Missouri law.
- 26. Furthermore, Burkhart has violated 700.100.3(4) in that it has employed deception, fraud, false pretense, false promise, misrepresentation, unfair practice or the concealment, suppression, or omission of any material fact in connection with the sale or of manufactured homes commerce, in or from the state of Missouri.

## COUNT III AUTHORITY TO SEEK PENALTIES

27. The Director re-alleges and incorporates herein the allegations and information contained in paragraphs 1-26.

- 28. Formal non renewal of Burkhart's 2010 Application for Renewal of Dealer Registration is appropriate because Burkhart has failed to provide a Certificate of No Tax Due, sold three new, red-tagged homes and one used, red tagged home in multiple violations of state law. Furthermore, Burkhart's dealer registration should not be renewed because the Company has been administratively dissolved by the Missouri Secretary of State and by statute the company is not authorized to do business in Missouri.
- 29. Based on the above allegations and Counts I through III against Burkhart, the Director requests the Commission authorize its General to seek penalties in circuit court, pursuant to Section 700.115.2, as each day's violation of Sections 700.010 through 700.115 is a separate offense and renders Burkhart liable for a penalty of up to \$1,000 for each offense.

WHEREFORE, the Director respectfully requests that the Commission, as enumerated in Counts I through III above, issue an order that:

- (1) Finds that Burkhart's application for renewal of registration is deficient in that Burkhart failed to file a No Tax Due certificate as required under Section 700.100.3.
- (2) Finds that Burkhart is not authorized to do business in the State of Missouri according to the Missouri Secretary of State.
- (3) Finds that Burkhart improperly sold or offered for sale four homes on four occasions without a valid dealer's registration as required under Sect Section 700.045.
- (4) Formally non-renew Burkhart's application for renewal of registration.
- (5) Authorizes the commission's General Counsel to seek penalties in Circuit Court in this matter.
