ORDER APPOINTING MEDIATOR

On February 26, 2018, the Manager of the Manufactured Homes and Modular Units Program of the Missouri Public Service Commission (Manager) filed a *Complaint* against Thomas Smith, an individual, asserting allegations related to the installation of a manufactured home. On February 27, 2018, the Commission issued its *Notice of Contested Case and Order Directing Filings*, ordering Mr. Smith to file an answer to the *Complaint* or to request mediation no later than March 29, 2018. Although Mr. Smith did not file by the deadline, he did submit a request for mediation on April 9, 2018, and the Manager has agreed to mediation. Therefore, as permitted by 4 CSR 240-2.125, the Commission will stay all other proceedings in this matter while the parties mediate.

Pursuant to Commission Rule 4 CSR 240-2.125(2), the Commission hereby appoints John T. Clark, Regulatory Law Judge, as Mediator. The Mediator shall convene an initial conference and each party shall be prepared to present its position

informally to the Mediator at the initial conference. In order to ensure the impartiality of the Presiding Officer and the Commission should mediation fail to resolve the dispute, no materials utilized for mediation shall be filed under this file number.

THE COMMISSION ORDERS THAT:

- 1. This case is stayed pending the outcome of mediation.
- 2. John T. Clark, Regulatory Law Judge, is appointed as Mediator.
- 3. This order shall be effective when issued.
