**FILING MEMORANDUM OF  
KANSAS CITY POWER & LIGHT COMPANY**

COMES NOW Kansas City Power & Light Company (“KCP&L”), and in response to the Order Directing Filing issued on March 9, 2010, hereby states as follows:

1. On March 9, 2010, the Commission Staff (“Staff”) filed the “Staff’s Reply to KCPL’s And GMO’s February 16, 2010 Response in Case Nos. ER-2009-0089 and ER-2009-0090 (“Staff Reply”). Staff filed the Staff Reply as being Highly Confidential and requested that KCP&L identify which portions of the Staff Reply that KCP&L believes should be designated highly confidential, proprietary or public.

2. On March 9, 2010, Senior Regulatory Law Judge Harold Stearley issued his Order Granting Request to Late-File Reply and Directing Filing which ordered KCP&L to file, no later than April 1, 2010, a pleading identifying which portions of the Staff Reply should be designated as confidential, proprietary, or public.

3. On March 15, 2010, Judge Stearley also issued his Order Establishing Investigatory Docket and Setting On-The-Record Proceeding in Case No. EO-2010-0259 which, among other things, closed Case Nos. ER-2009-0089 and ER-2009-0090, and transferred all filings and discovery related matters to the construction audit to Case No. EO-2010-0259.

4. In response to the Order Directing Filing issued on March 9, 2010, KCP&L has reviewed the Staff Reply filed on March 9, 2010, and has attached a highly confidential,

proprietary, and public version of the Staff Reply filed in Case Nos. ER-2009-0089 and ER-2009-0090, and subsequently transferred to Case No. EO-2010-0259, and requests that the Commission accept these versions of the Staff Reply for filing in this case.
