
LIST OF ISSUES

COME NOW the Complainant, Summit Investments, L.L.C. (hereinafter, "Summit"), the Respondent, Osage Water Company ("Osage"), the Staff of the Missouri Public Service Commission ("Staff"), and the Office of Public Counsel ("OPC"), by and through counsel, and submit the following List of Issues.

1. Did Osage fail to provide adequate water service to all the customers and lots at the Eagle Woods Subdivision in Camden County, Missouri ("Eagle Woods")? If so, when did each such failure begin and end, and does the failure still exist?
2. Did Osage fail to comply with its water tariff on file with the Commission, in providing water service to all the customers/lots at Eagle Woods? If so, when did each such failure begin and end, and does the failure still exist?
3. Did Osage fail to comply with any other Commission rules or requirements in providing water service to all the customers/lots at Eagle Woods? If so, when did each such failure begin and end, and does the failure still exist?
4. Can the existing water supply system at Eagle Woods be used to lawfully and adequately serve the remaining residential customers/lots in Eagle Woods?

5. What actions, if any, must Osage take to render the water service at Eagle Woods "safe and adequate"?
6. Did Osage fail to provide adequate sewer service to all the customers/lots at the Eagle Woods Subdivision in Camden County, Missouri ("Eagle Woods")? If so, when did each such failure begin and end, and does the failure still exist?
7. Did Osage fail to comply with its sewer tariff on file with the Commission, in providing sewer service to all the customers/lots at Eagle Woods? If so, when did each such failure begin and end, and does the failure still exist?
8. Did Osage fail to comply with any other Commission rules or requirements in providing sewer service to all the customers/lots at Eagle Woods? If so, when did each such failure begin and end, and does the failure still exist?
9. Can the existing sewer system at Eagle Woods be used to lawfully and adequately serve the remaining residential customers/lots in Eagle Woods?
10. What actions, if any, must Osage take to render the sewer service at Eagle Woods "safe and adequate"?
