**COMES NOW** Laclede Gas Company (“Laclede” or “Company”) and, after consultation with the Staff of the Missouri Public Service Commission (“Staff”), the Office of the Public Counsel (“Public Counsel”) and USW Local 11-6 (the “Union”), submits this list of issues and witnesses, and order of opening statements and cross-examination, stating as follows:

  - C. (i) May Laclede and MGE submit estimated “budget” ISRS investments in the petition that are later replaced with actual ISRS investments?; and  
(ii) May Laclede and MGE update reserves for depreciation and accumulated deferred income taxes related to actual ISRS investment

amounts (including amounts from previously incurred ISRS costs since the current ISRS was established)?
