On July 16, 2021, Spectrum Mid-America, LLC (“the Company”) pursuant to Section 67.2679.7, RSMo 2016, filed a Notice of Change Application seeking to expand video service to the following political subdivisions:

1. Spectrum Mid-America, LLC is granted authority to provide video service in the franchise area of each political subdivision set forth in the application and restated above.
2. Spectrum Mid-America, LLC is granted authority to construct a video service

network along, across, or on public rights-of-way for the delivery of video service to the extent the video service provider or an affiliate did not otherwise possess a valid authorization to occupy the public rights-of-way.

3. This order shall become effective when issued, after which this file may be closed.
