2	Q.	Please state your name and business address.
3	A.	My name is Matthew A. Lueders. My business address is 727 Craig Road, Creve Coeur,
4		MO 63141.
5	Q.	By whom are you employed and in what capacity?
6	A.	I am employed by Missouri-American Water Company (MAWC or the Company) as
7		Deputy Director of Engineering.
8	Q.	Please summarize your educational background and business experience.
9	A.	I received a Master of Science Degree in Environmental Engineering in 2008, and a
10		Bachelor of Science in Engineering Management in 2004, from the Missouri University of
11		Science and Technology. I am registered as a professional engineer in Missouri and
12		Indiana. I have more than 14 years of experience in water and wastewater system
13		engineering.
14		From 2008 to 2011, I worked as an engineer for Indiana American Water, and from 2011
15		to 2019, I worked as an engineer for MAWC. In these two roles I authored or co-authored
16		more than 10 comprehensive planning studies, which guided the capital program for more
17		than 60 water and wastewater systems and developed numerous targeted studies supporting
18		engineering design and operations. In 2019, I was promoted to Engineering Manager for
19		Capital Asset Planning at MAWC, where I was responsible for all water and wastewater
20		capital planning. In 2022, I was promoted to Deputy Director of Engineering for MAWC.

What are your current employment responsibilities?

- 1 A. As Deputy Director of Engineering, I oversee and manage the activities and groups supporting comprehensive water and wastewater planning, geographic information 2 3 systems (GIS) and mapping, supervisory control and data acquisition (SCADA) systems, developer related services, and new system acquisitions. My responsibilities include 4 5 maintaining compliance with state and federal requirements related to the planning of the 6 capital investment program; providing comprehensive system planning for use in 7 developing system needs and projecting capital spending; supporting MAWC operations staff in performing plant/system troubleshooting and supporting the proper implementation 8 9 and maintenance of the SCADA system. I am also responsible for the acquisition and 10 integration process for new water and wastewater systems. As a Deputy Director of Engineering, I am familiar with the facilities and operations of the Company in each of its 11 operating areas. 12
- 13 Q. Did you provide Direct Testimony in this case?
- 14 A. No, I did not.
- 15 Q. Are you adopting any Direct Testimony in this case?
- 16 A. Yes. I am adopting portions of the Direct Testimony of Rebecca Losli, including Section
  17 II "Capital Investment Program", Section IV "Water Storage Tank Rehabilitation" and
  18 Section V "Risk of Providing Public Water and Wastewater Services".
- Q. If you were asked the same questions as those asked in Ms. Losli's Direct Testimony,
   would your responses be the same?
- 21 A. Yes.
- 22 Q. What is the purpose of your Rebuttal Testimony?

1 A. The purpose of my Rebuttal Testimony is to respond to Office of the Public Counsel (OPC)

2 witness Geoff Marke regarding lead line replacement funding.

#### II. LEAD LINE REPLACEMENT FUNDING

- Q. Dr. Marke indicates his belief that MAWC has not taken a proactive effort in securing federal funding to provide least cost service to its captive ratepayers for lead line service remediation. Do you agree with this statement?
- 7 A. No. MAWC has submitted multiple applications to obtain federal funding.
- Q. Dr. Marke stated that "MAWC should provide a detailed response in rebuttal as to how it plans to secure federal funding, identify and inform customers moving forward, and other tangible actions." How do you respond to this statement?
- 11 A. MAWC actively reviews opportunities for state and federal funding to assist with the cost
  12 of infrastructure replacement. MAWC is engaged in applying for applicable funds.
  13 MAWC's commitment to this issue is demonstrated by the following:
  - MAWC was awarded more than \$11.2 million in financial assistance from the Missouri Department of Natural Resources for upgrades to its water treatment plant in Jefferson City. The project included the replacement of a below-grade clearwell and high-service pumping facility and routing discharge to a new finished water line connected to the distribution system. Other improvements included a new reinforced concrete duct bank, a new generator and other electrical system upgrades. The project's funding consists of a Drinking Water State Revolving Fund loan. This funding is estimated to save Missouri American customers approximately \$2.1 million in interest during the loan's

1 20-year term.

- MAWC and American Water have advocated, and will continue to advocate, for
  Congress to expand the eligibility of Clean Water State Revolving Fund loans for
  wastewater projects so that it has access to low-interest loas for wastewater systems.
   Currently, investor-owned utilities are only eligible for SRF loans for drinking water
  projects.
  - MAWC has applied for the maximum amount of \$200,000 in grant assistance under
    the American Rescue Plan Act 2021 (ARPA) to support the lead service line
    inventory. However, MAWC's grant application was not selected for funding. The
    response from the Missouri Department of Natural Resources ARPA Team is
    included herein as Schedule-MAL-1 RT.
  - MAWC has applied but was not selected for the maximum amount of \$5,000,000 in ARPA grant assistance for drinking water projects to support upgrades to its water treatment plant in Jefferson City. The project included replacement of the existing secondary clarification basins, which were constructed in 1927, with new secondary clarification basins along with integral primary and secondary re-carbonation basins. The response from the Missouri Department of Natural Resources ARPA Team is included herein as **Schedule-MAL-2 RT**.
  - MAWC has applied for but was informed that it was not selected for the maximum amount of \$5,000,000 in ARPA grant assistance for wastewater projects to support upgrades to its wastewater treatment facilities near Wardsville, MO. This project included a new treatment plant at the Wardsville NW site, as well as lift stations and

- 1 forcemain to replace multiple satellite treatment facilities and meet upcoming
- 2 regulatory requirements. The response from the Missouri Department of Natural
- Resources ARPA Team is included herein as **Schedule-MAL-3 RT**.
- 4 MAWC will continue to advocate for programs that provide loan assistance to investor-
- 5 owned water and wastewater systems. MAWC will also continue to apply for available
- 6 funds from state and federal resources when applicable.
