LIST OF ISSUES, WITNESSES, AND ORDER OF CROSS-EXAMINATION

COME NOW the Staff of the Missouri Public Service Commission (Staff), through Counsel, on behalf of the Office of Public Counsel (OPC), Laclede Gas Company (Laclede), and Dr. Hortense Lucinda Harrison (Dr. Harrison), collectively known as the Parties, and file this List of Issues, Witnesses and Order of Cross-Examination for the upcoming August 20, 2008 hearing. Staff, on behalf of the Parties, respectfully states to the Missouri Public Service Commission (Commission) the following:

List Of Issues

- 1. On July 1, 2008, the Commission issued its Order Denying Laclede's Motion to Strike OPC's Post-Hearing Brief and Reopening the Record for Receipt of Additional Evidence. The Order stated "the Commission will reopen the record and permit the parties to present additional evidence on all the issues raised in OPC's brief."
- 2. The issues raised in OPC's June 2, 2008 post-hearing brief, and those to be decided by the Commission are as follows:
 - a. Did Laclede violate its tariff or Commission rules in rendering estimated bills to
 Dr. Harrison between December 2006 and March 2007?

- b. Did Laclede violate Commission rule 13.025(1)(B) when it issued an adjusted bill to Dr. Harrison for a period ending on March 27, 2007?
- c. Did Laclede violate 4 CSR 240-13.030 regarding deposits?
- d. Did Laclede violate 4 CSR 240-13.050 regarding disconnection?

Witnesses

- 3. OPC has indicated it will not be calling any witnesses.
- 4. To date, Dr. Harrison has not indicated to Counsel for Staff whether she will testify herself, or call any witnesses. On August 5, 2008, Counsel for Staff attempted to contact Dr. Harrison by email and phone to request witness information. Counsel for Staff received an email from Dr. Harrison on August 5, 2008, but it was unresponsive to the information requested.
- 5. Laclede has indicated Rhonda O'Farrell will testify on its behalf.
- 6. Marilyn Doerhoff will testify on behalf of Staff.

Order Of Cross-Examination

- 7. Dr. Harrison, if she testifies or presents witnesses, will present evidence first, followed by cross-examination by OPC, Staff, and Laclede.
- 8. Staff will present evidence next, followed by cross-examination by Laclede, Dr. Harrison, and OPC.
- 9. Laclede will present evidence last, followed by cross-examination by Staff, Dr.Harrison, and OPC.

WHEREFORE, Staff respectfully requests that the Missouri Public Service Commission accept the List of Issues, Witnesses and Order of Cross-Examination in this case.
