**MOTION TO WITHDRAW TARIFF**

Comes now Sprint Missouri, Inc. (Sprint), and hereby withdraws its tariff filed on January 30, 2003. In support of this Motion, Sprint states as follows:

1. On January 30, 2003, Sprint filed the tariff that initiated this case. The Sprint tariff filed in this case seeks to increase the maximum allowable rates for Sprint's business and residential MCA Plan offerings. On February 20, 2003, the Commission suspended the tariff until November 30, 2003.

2. On February 27, 2003, the Commission issued an order setting a Pre-Hearing Conference for March 14, 2003. On March 6, 2003, Sprint filed its Motion to Consolidate the Pre-Hearing Conference in this case with the Pre-Hearing Conference in Case No. IT-2003-0292. On March 7, 2003, Sprint's Motion to Consolidate was granted by the Commission.

3. Sprint now moves to withdraw the tariff filing that initiated this case. To date, other than Sprint's Motion to Consolidate, no party has filed a pleading in this case. Further, the other parties, the Commission Staff and the Office of Public Counsel do not oppose this motion. Therefore, no party is prejudiced by the granting of this motion.

WHEREFORE, Sprint Missouri, Inc. requests that it be allowed to withdraw its tariff and that this case be closed.
