ITC MIDWEST LLC'S MOTION FOR WAIVER OR VARIANCE

Comes Now ITC Midwest LLC ("ITCMW"), and for its Motion for Waiver or Variance of Rule 4 CSR 240-2.135 states as follows:

1. On March 13, 2013, the Commission issued herein its Order Regarding Staff Recommendation and Motion for A Waiver or Variance. In its Order, the Commission directs ITCMW to comply with recommendations made by Staff in the Report submitted on February 8, 2013.

2. Staff's Report has been classified as Highly Confidential in its entirety and, therefore, counsel for ITCMW is not able to inform anyone at the company as to what it has been directed to do.

3. In its Order, the Commission granted a waiver or variance of Rule 4 CSR 240-2.135 to The Empire District Electric Company so that it could share the Staff Report with its employees. ITCMW requires similar relief in order to be able to comply with the Commission's Order. ITCMW can accept the conditions that the Commission imposed on that grant, namely the ITCMW will be responsible for requiring employees with whom information from the Staff's Report is shared to adhere to non-disclosure agreements pertaining thereto that ITCMW will maintain and make available as ordered by the Commission.

WHEREFORE, ITC Midwest LLC requests a waiver or variance of Rule 4 CSR 240-2.135 as described herein.
