ITC MIDSOUTH LLC'S MOTION TO REVISE BRIEFING SCHEDULE

COMES NOW ITC Midsouth LLC ("ITC Midsouth"), pursuant to 4 CSR 240-2.140, and for its Motion to Revise Briefing Schedule states as follows:

- 1. The hearings in this matter concluded on June 18, 2012 after less than a full day.
- 2. By order dated April 18, 2013, the Commission set a briefing schedule of July 12 for initial briefs and August 2 for reply briefs.
- 3. At the conclusion of the hearing, ITC proposed a revised briefing schedule of July 8 for initial briefs and July 18 for reply briefs. Counsel for the other joint applicants and counsel for staff supported the proposal, but counsel for intervenors expressed opposition. ITC was directed to file a motion.
- 4. Based on opposition expressed relative to the timing of the initial briefs and the July 4 holiday, ITC proposes to leave the due date for initial briefs at July 12.

5. However, given that the standard due date pursuant to rule 2.140(3) for reply briefs would be ten days later on July 22, ITC moves the Commission to change the current schedule to adopt that due date.

6. The parties have had access to most of the testimony for months, and the more recent surrebuttal and live testimony was very limited. Initial briefs will certainly address opposing positions. Ten days should be more than enough time for replies.

7. In the interest of eliminating any avoidable delays, ITC requests that the Commission move up the due date for reply briefs.

WHEREFORE, ITC Midsouth LLC moves the Commission to revise the briefing schedule in this matter and order that initial briefs be filed by July 12, 2013 and reply briefs be filed by July 22, 2013.
