COMES NOW Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC Missouri") and, for its Notice of Dismissal of Tariff, states as follows:

- 1. On October 16, 2002, SBC Missouri submitted a proposed tariff revision to grandfather its current wireless 9-1-1 offering and to introduce a new Wireless 9-1-1 Tariff that addresses both Phase I and Phase II E-911 service.
- 2. On October 24, 2002, the Office of Public Counsel filed a Motion to Suspend and Request for an Evidentiary Hearing.
- 3. On November 7, 2002, the Missouri Public Service Commission ("Commission") entered its <u>Order Regarding Tariffs</u>, suspending SWBT's tariff for a period of 120 days plus six months until September 13, 2003, unless otherwise ordered by the Commission.
- 4. On January 9, 2003, the Commission entered its <u>Order Establishing Procedural Schedule</u> ("<u>Order</u>"). In that <u>Order</u>, the Commission established the following procedural schedule:

SBC Missouri's Direct Testimony March 7, 2003

Other Parties' Rebuttal Testimony March 28, 2003

All Parties' Surrebuttal Testimony April 18, 2003

Issue List, Order of Witnesses, Order April 25, 2003 of Cross Examination and Position Statements

Evidentiary Hearing

May 5-7, 2003.

5. Pursuant to 4 CSR 240-2.116, SBC Missouri may voluntarily dismiss a proposed tariff prior to the filing of testimony. SBC Missouri has determined that it is appropriate to withdraw its tariff at this time.

WHEREFORE, SBC Missouri respectfully requests the Commission to accept this Notice of Dismissal of Tariff and to dismiss this proceeding.
