<u>APPLICATION TO INTERVENE OF MISSOURI GAS ENERGY</u>

COMES NOW Missouri Gas Energy ("MGE"), an operating division of Southern Union Company ("Southern Union") by counsel, pursuant to 4 CSR 240-2.075, and for its application to intervene in the above-captioned proceeding states as follows to the Missouri Public Service Commission (the "Commission"):

- 1. Southern Union is a Delaware corporation and conducts business in Missouri through its MGE operating division. Through MGE, Southern Union is a "gas corporation" and "public utility" as those terms are defined in Section 386.020 RSMo and as such is subject to jurisdiction of the Commission as provided by law.
- 2. MGE's principal Missouri office is located at 3420 Broadway, Kansas City, Missouri 64111.

4. On April 27, 2011, Southern Missouri Gas Company, L.P., d/b/a Southern Missouri Natural Gas ("SMNG") and Missouri Gas Utility ("MGU") filed an application that requests,

among other things, authority from the Commission for SMNG and MGU to merge, with MGU as

the surviving entity.

5. By the Commission's Order issued April 28, 2011, the Commission established an

intervention deadline of May 18, 2011.

6. MGE should be allowed to intervene in this proceeding because it has an interest that

is different from that of the "general public" which may be adversely affected by a final order in

this case. MGU's current operating area runs adjacent to the certain areas of MGE's service

territory. Additionally, as noted in Case No. GA-2010-0189, certain MGU's pipelines cross

MGE's natural gas distribution lines.

7. MGE and MGU entered a Stipulation and Agreement in GA-2010-0189 to address

certain operating issues due to the proximity of service territories and similarity of names

between the two utilities. MGE wants to ensure that similar operational issues are addressed

with the surviving entity of the proposed merger. MGE also wants to address any other issues

that that may be of concern to MGE during the course of discovery in the present case. MGE is

still analyzing the present case to determine what, if any impact there may be with respect to

operational or other issues.

WHEREFORE, for the reasons stated herein, MGE respectfully requests that the

Commission issue an order permitting it to intervene in this case with full rights as a party

hereto.
