APPLICATION TO INTERVENE OF KANSAS CITY POWER & LIGHT COMPANY AND KCP&L GREATER MISSOURI OPERATIONS COMPANY

COMES NOW Kansas City Power & Light Company ("KCP&L") and KCP&L Greater Missouri Operations Company ("GMO") (collectively, the "Companies"), pursuant to 4 CSR 240-2.075 and hereby apply to intervene and to become parties to the above-captioned case. In support thereof, the Companies state as follows:

- 1. KCP&L is a Missouri corporation, in good standing in all respects, with its principal office and place of business located at 1200 Main Street, Kansas City, Missouri 64105. KCP&L is engaged in the generation, transmission, distribution, and sale of electric energy and power in those areas in Missouri certificated to it by the Missouri Public Service Commission (hereinafter "Commission"), including the City of Kansas City, Missouri, as well as in areas of eastern Kansas. KCP&L's Certificate of Good Standing was filed with the Commission in Case No. EF-2010-0178 and is incorporated herein by reference.
- 2. GMO is a Delaware corporation with its principal office and place of business also at 1200 Main, Kansas City, Missouri 64105. GMO is primarily engaged in the business of generating, transmitting, distributing, and selling electric energy in those portions of northwestern Missouri certificated to it by the Commission. GMO provided its Certificate of Good Standing and its certificate authorizing it to do business in Missouri as a foreign corporation in Case No. EN-2009-0164 which is incorporated herein by reference.

3. The Companies are "electrical corporations" and "public utilities" as those terms

are defined in Mo. Rev. Stat. § 386.020 (2000), and as such, are subject to the jurisdiction of the

Commission as provided by law.

4. The Companies have a direct and pecuniary interest in this proceeding that is

different from the general public. As indicated in its Notice of Intended Case Filing in File No.

EO-2014-0095, KCP&L anticipates filing its application concerning demand-side programs and

a Demand-Side Programs Investment Mechanism before year end. GMO has demand-side

programs and a Demand-Side Investment Mechanism in place stemming from its application in

Case No. EO-2012-0009.

5. Because both Companies have or will have demand-side programs and a

Demand-Side Investment Mechanism, the Companies' interest in this proceeding is different

from that of the general public and cannot be represented by any other party to these

proceedings. Actions taken by the Commission in this proceeding may substantially affect the

Companies' legal interests.

6. The Companies' participation will aid the Commission in resolving the issues

raised in this proceeding. Consequently, the Companies' intervention and participation will

promote the public interest.
