On March 30, 2006, the Staff of the Public Service Commission; Cass County Telephone Company, Limited Partnership; Local Exchange Company, LLC; FairPoint Communications, Inc.; FairPoint Communications Missouri, Inc.; and the Office of the Public Counsel filed a Stipulation and Agreement that purports to resolve Staff's investigation into the earnings of Cass County Telephone Company.

The Commission finds that notice of this Stipulation and Agreement should be given to the general public and to potentially interested parties. A date for intervention of proper parties will also be set. If no proper party is granted intervention and no party requests a hearing, the Commission may determine that a hearing is not necessary.
