**STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its Status Report states as follows:

1. On June 2, 2010, the Commission issued an Order Setting Hearing Date giving notice to parties that an evidentiary hearing will be held on June 24, 2010 beginning at 8:30 a.m.
2. On April 15, 2010, Peter N. Brown and Cynthia Goldsby were served subpoenas *duces tecum*. Subsequently, Mr. Brown and Ms. Goldsby submitted affidavits answering specific questions and Mr. Brown provided documents to Staff. Therefore, Staff will not execute its subpoenas *duces tecum* on Mr. Brown and Ms. Goldsby.
3. On April 15, 2010, John Summers and Vernon Stump were served subpoenas *duces tecum*. In light of the answers and documentation Staff received from other respondents, Staff will not execute those subpoenas *duces tecum*.
4. On April 16, 2010, RPS Properties was served a subpoena *duces tecum*. Subsequently, RPS's Properties submitted affidavits answering specific questions and provided documents to Staff; therefore Staff will not execute its subpoena *duces tecum*.
5. On April 21, 2010, Sally Stump was served a subpoena *duces tecum*. Subsequently, she submitted an affidavit answering specific questions; therefore, Staff will not execute its subpoena *duces tecum*.
