COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its *List of Issues and Witnesses*, states as follows:

1. On January 22, 2007, Irene D’Souza of 3708 W. Rollins, Columbia, Missouri 65201 (Complainant) initiated this proceeding by filing a Complaint against AmerenUE.
2. On June 25, 2007, AmerenUE filed its Answer to Ms. D’Souza’s complaint, in which the Company denied any violation of its tariff or Commission regulations.
3. On July 16, 2007, the Staff of the Missouri Public Service Commission (Staff) filed its Report, finding no violation of applicable statutes, Commission regulation or AmerenUE tariffs.
4. On September 10, 2007, the Commission issued an *Order Setting Complaint for Hearing* (Order). The Order set this matter for hearing on September 27, 2007. The Order also required all parties to file a list of issues and witnesses by September 24, 2007.

5. AmerenUE believes there is only one question at issue:

Did AmerenUE violate any of the Commission rules, any state statute or any of its tariffs when it billed Ms. D'Souza for natural gas usage at 1301 West Broadway in Columbia, Missouri?

6. AmerenUE intends to call one witness: Debra Buhr, Supervisor, Customer Service.

WHEREFORE, AmerenUE respectfully requests that the Commission accept this pleading in response to the Commission's September 10, 2007 Order.
