ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF

Issue Date: January 13, 2010

Effective Date: January 13, 2010

The Missouri Public Service Commission is approving a substitute tariff implementing a name change from MCC Telephony of Missouri, Inc., to MCC Telephony of Missouri, LLC, and granting the name change application.¹

The Commission received the application on September 8, 2009, with an implementing tariff. On December 22 and 23, 2009, the Commission received a tariff and substitute tariffs to which the Commission assigned Tracking No. YL-2010-0411. On January 8, 2010, the Commission's staff filed a recommendation, with its report favoring the grant of the application and approval of the substitute tariff, and supporting affidavit.

Because no party disputes the application, no law requires a hearing before granting the application, so the Commission convened no hearing and bases its findings

on the verified report.² The application complies with the Commission's regulation requiring the application to include:

- (A) A statement, clearly setting out both the old name and the new name;
- (B) Evidence of registration of the name change with the Missouri secretary of state; and
- (C) Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application. Also, no annual report, no annual assessment fee, and no Missouri Universal Service Fund remittance are past due from the applicant. Therefore, the Commission will grant the application and approve a substitute tariff.

THE COMMISSION ORDERS THAT:

1. The application for recognition of name change from MCC Telephony of Missouri, Inc., to MCC Telephony of Missouri, LLC, is granted.

2. The following tariff sheet ("tariff") is approved to become effective on January 22, 2010:

Second Revised Page 1, Replacing First Revised Page 1

3. The specific tariff approved is the substitute tariff issued on December 23, 2009; filed on that same date at 9:38:33 a.m. under Tracking No. YL-2010-0411; and listed in the Commission's Electronic Filing and Information System as item no. 8.

4. This file may close on January 23, 2010.
