STAFF'S STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission and for its status report states:

- 1. On December 31, 2007, Comcast IP Phone of Missouri, LLC d/b/a Comcast Digital Voice ("Comcast") applied to the Missouri Public Service Commission for a certificate of service authority to provide local exchange and interexchange telecommunications services in Missouri, and for designation as a competitive telecommunications carrier in the service territories of AT&T, Embarq, CenturyTel and Spectra. Comcast sought the standard waivers, but also included a request for certain additional waivers.
- 2. On February 14, 2008, the Commission ordered the Staff to file, no later than February 28, a pleading informing the Commission when it will be able to file its recommendation in this matter.
- 3. In its February 28 pleading, the Staff responded that it was participating in ongoing discussions with Comcast, that Staff may find it useful to follow up with data requests, and that Staff planned to file its recommendation no later than April 1, 2008.
- 4. During conference calls on February 27, March 3, and March 25, 2008, the Staff and Comcast have discussed Comcast's request for the additional waivers. In addition, the Staff has sent, and Comcast has responded to numerous informal data requests. Light follow up

remains pending. Because of the potential for setting a precedent and because of the complexity of the request for the additional waivers, the Staff needs an additional two to three weeks to complete its analysis and prepare a recommendation. Accordingly, the Staff plans to file its recommendation no later than April 22, 2008.

5. Comcast does not object to Staff's proposal to file its recommendation no later than April 22, 2008.

WHEREFORE, the Staff plans to file its recommendation no later than April 22, 2008.
