**AMENDMENT BY INTERLINEATION
OF JOINT APPLICATION**

COME NOW Missouri-American Water Company (MAWC) and Loma Linda Water Company (Loma Linda) and for their Amendment by Interlineation of Joint Application state as follows:

1. The first sentence of Paragraph 10 of the Joint Application is amended so that the entire paragraph now states as follows:

10. MAWC intends that, at and from the time MAWC acquires the assets of Loma Linda at closing, the Loma Linda customers will pay Loma Linda's rates currently in effect until such time as those rates may be modified according to law. In addition, MAWC intends that, at and from the time MAWC acquires the assets of Loma Linda at closing, MAWC's Rules, Regulations and Conditions of Service governing its Joplin District shall apply to the Loma Linda customers until such time as those Rules, Regulations and Conditions of Service may be modified according to law.

2. In all other respects, MAWC and Loma Linda restate and readopt their Joint Application.
