## AMENDED MOTION FOR EXPEDITED TREATMENT OF AMENDED TARIFF

COMES NOW Missouri-American Water Company (MAWC) and for its Amended Motion for Expedited Treatment of Amended Tariff (Amended Motion) states as follows:

1. In its November 3, 2010 Order Approving Transfer of Assets (Order), the Missouri Public Service Commission ordered MAWC to "notify the Commission within five business days after the assets have been transferred."

2. MAWC notified the Commission on January 21, 2011 that the assets had been transferred earlier that day.

3. The Order also states: "Upon transfer of the assets, Missouri-American Water Company shall amend its Joplin tariff to include the area previously served by Loma Linda Water Company."

4. MAWC filed the amended sheets of its Joplin tariff contemporaneously with its Notice of Transfer of Assets and Motion for Expedited Treatment of Amended Tariff (Original Motion), with a Date of Issue of January 21, 2001 for the amended tariff.

5. An amended tariff generally becomes effective 30 days after date of issue. MAWC is seeking expedited treatment for the approval of the amended tariff within 10 days of January 21, 2011, that is, January 31, 2011. There will be no negative effect on MAWC's new customers in Loma Linda, or on the general public, if the Commission acts by January 31, 2011.

6. The Original Motion was filed as soon as it could have been – the very same day the assets of Loma Linda Water Company were transferred to MAWC, per the Commission's Order that the amended Joplin tariff be filed "upon transfer of the assets."

7. MAWC is filing the Amended Motion because the Original Sheet 3B filed with its Original Motion inadvertently omitted the Golf Course Irrigation Rate. A copy of the revised Original Sheet 3B, which should replace the Original Sheet 3B filed with the Original Motion, is attached as Exhibit A.

WHEREFORE, MAWC prays that the Commission issue its order approving the amended sheets, including the Original Sheet 3B filed herewith, of MAWC's Joplin tariff by January 31, 2011.

## SCHEDULE OF RATES **RESIDENTIAL RATE** The minimum monthly rate is as follows: Meter size 5/8" or less \$ 5.48 1" 13.70 1 1/2" 27.41 2" 43.85 3" 82.23 4" 137.04 Commodity Charge \$2.47 per 1,000 gallons or \$1.8525 per 100 cubic feet The residential rate applies to all domestic use, whether for single family residences or multi-family residences served by a single meter and used primarily for non-business, non-commercial or non-industrial purposes. **COMMERCIAL RATE** The minimum monthly rate is as follows: Meter size 5/8" or less \$ 5.48 1" 13.70 1 1/3" 27.41 2" 43.85 3" 82.23 4" 137.04 Commodity Charge \$2.47 per 1,000 gallons or \$1.8525 per 100 cubic feet The commercial rate applies to all-use which does not qualify for any other rate schedule. **GOLF COURSE IRRIGATION RATE** Untreated water used off peak demand periods for golf course irrigation when the backup well is not required to provide an adequate supply of water to the Company's other customers will be billed at a rate of \$0.93 per thousand gallons. **GROSS RECEIPTS OCCUPATION, FRANCHISE OR OTHER TAXES AND FEES** There shall be added to the Customer's bill, as a separate item, an amount equal to the proportionate part of any license, occupation, franchise or other similar fee or tax now or hereafter imposed upon the Company by any municipality or any other governmental authority, whether imposed by ordinance, franchise or otherwise in which the fee or tax is based upon a percentage of gross receipts, net receipts or revenue from the sale of water service rendered by the company to the Customer or is based upon the number of connections to the water system. Bills will be increased the proportionate amount only in the service area where such tax is applicable.
