Dear Customer:

After implementing professional operations and investing nearly \$29,000,000 in improving water and wastewater infrastructure in communities such as yours across Missouri, Confluence Rivers Utility Operating Company ("Confluence Rivers") is working to ensure you have access to clean, safe and reliable drinking water and wastewater systems.

As a result of our investments, in December 2022, Confluence Rivers submitted a request to the Missouri Public Service Commission ("MoPSC") for an increase in its annual water operating revenues of \$1,286,748, and an increase in its annual sewer operating revenues of \$1,862,116. The improvements to the drinking water systems include remote monitoring equipment at each location to ensure that facilities are closely monitored and working properly at all times, improving overall efficiency, and proactively working to prevent potential problems that might not otherwise be detected in aging systems. Additional investments include the implementation of chlorination equipment and analyzers, repair of storage tanks, and the installation of new booster pumps. Our improvements to wastewater facilities include basic system repairs at each location, remote monitoring, plant improvements to ensure removal of ammonia, a toxic pollutant, to comply with Missouri Department of Natural Resources ("DNR") and Environmental Protection Agency ("EPA") regulations, plus structural improvements where needed.

Public Hearing Information

The MoPSC is holding several public hearings where customers can ask questions and testify about the company's rate request. Customers are encouraged to participate in the hearings.

Each hearing is divided into two parts. In the first part, you may ask questions of Confluence Rivers, the Missouri Office of the Public Counsel ("OPC"), and the MoPSC Staff. The MoPSC Commissioners and the regulatory law judge will not attend the informal question and answer session. Your questions and the answers provided will not be part of the evidence the MoPSC reviews. In the second part, MoPSC Commissioners and a regulatory law judge will be present, and you may testify as part of the official record of the case.
