**NOTICE OF CHANGE APPLICATION AND  
NOTICE OF CORRECTION**

COMES NOW AT&T Missouri,<sup>1</sup> pursuant to Section 67.2679.6 RSMo 2000 (Cum. Supp. 2007), and for its Notice of Change Application seeking to expand video service to additional areas, states as follows:

1. AT&T Missouri's principal Missouri office is 909 Chestnut Street, One AT&T Center, Room 3520, St. Louis, Missouri 63101.
2. AT&T Missouri seeks a franchise to provide video service in the following additional political subdivisions, which assess the following video service provider fees:

<b>Political Subdivision</b>	<b>Fee Amount</b>
Farmington	3%
Lake Lotawana	5%
North Kansas City	5%
Smithville	5%

3. AT&T Missouri restates each of the statements made in its Application for Video Service Authorization filed with the Missouri Public Service Commission ("Commission") on October 16, 2007, subject to its Notice of Correction filed with the Commission on November 16, 2007, and paragraph 5, below.
4. Attached is an affidavit signed by an officer of AT&T Missouri affirming this request.

5. AT&T Missouri further notifies the Commission that the franchise fee amount for each of Blue Springs, Riverside and Independence should be 3% (rather than 5%, as was shown in AT&T Missouri's Application and the Commission's Video Service Authorization).

WHEREFORE, AT&T Missouri requests that the Commission issue its order granting AT&T Missouri video service authorization for the additional political subdivisions listed above and an order correcting the franchise fee amounts for Blue Springs, Riverside and Independence.


