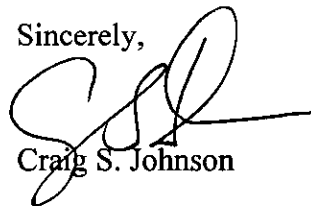

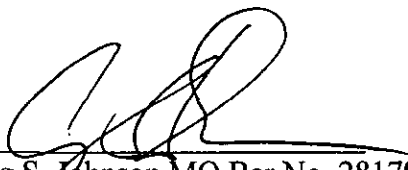
In support of this procedural schedule, the MITG submits the following:

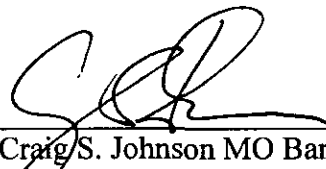
