MOTION TO ESTABLISH PROCEDURAL SCHEDULE

COMES NOW GTE Midwest Incorporated d/b/a Verizon Midwest ("Verizon"), pursuant to the Missouri Public Service Commission's ("Commission") Order of April 5, 2000 in this proceeding which ordered the parties to file a procedural schedule not later than September 22, 2000, and respectfully states to the Commission:

- 1. Verizon concurs in and supports the procedural schedule set forth in the "Joint Motion To Establish Procedural Schedule" filed this date by Southwestern Bell Telephone Company, Sprint Missouri, Inc. and the Staff of the Commission ("Joint Movants"). Verizon agrees with the joint movants that their proposed procedural schedule is reasonable and that it should not materially prejudice any party to this case.
